## **IMPORTANT GUIDELINES/ INFORMATION**

### **1. Roles & Responsibilities (WAKO India)**

- A. Finalization of the structure of the league/tournament in consultation with Sports Authority of India (SAI).
- B. Approval for branding, back drop, logo 'logo size, Position etc.
- C. Approval of list of invitees, minute to minute and branding for Opening/ Closing Ceremony.
- D. The Cities/locations of the league will be finalized by the Federation in consultation with State Associations.
- E. Deputation of Technical Officials, Competition Managers, referees and support staff.
- F. All branding related elements / templates will be provided by WAKO India
- G. Update about next edition of the tournament.
- H. Supervise the league and maintain record.
- I. Ensuring for equipment's and other requirements.
- J. Identify talented athletes based on skills. Shortlist talented athletes and ensure all shortlisted athletes are registered on Khelo India National Sports Repository System (NSRS) portal.
- K. Branding for press conferences or promotion of the League via various media, organise press conferences to be approved by WAKO India.
- L. All designing part shall be send by WAKO India Office after getting approval from SAI.



## 2. Roles & Responsibilities (Host Unit)

1. All the selected State/UT Kickboxing Associations may submit a request letter with date, venue & tournament schedule to WAKO India Office to conduct the "ASMITA" Women's Kickboxing City League" at least 1 weak prior to the date of Event in your city.
2. Host unit to have all permissions/ clearance regarding conduct of the league
3. State Associations/Host unit shall be responsible for the financial management of the event and budget of tournament.
4. Host unit shall Ensure registration of the "Teams/Participants, schedule of matches, results, management of database and publicity etc.'
5. Technical conduct to be ensured through qualified Referees/Technical officials.
6. Host unit ensure minimum 200 Women Participants in the league.
7. The competition will be conducted in accordance with the Rules & Regulations of the WAKO India (WAKO)
8. Ensuring recruitment of sufficient volunteers
9. A comprehensive Report to be submitted after the tournament along with a 30 seconds audio visual clip
10. Arrangement of medical facilities, including ambulance at the venue
11. Ensuring adequate security during the event
12. The team/participant to manage local travel, refreshment, medical kit, etc. on its Own
13. If the team/participant is from outstation, accommodation and transportation to be Managed at their own cost
14. The team should have a coach and manager.
15. Any Kickboxing Player can take part in any city event i.e. there is no restrictions to take part.
16. Host unit to organise, manage, coordinate and execute the Opening Ceremony with approval of WAKO India & SAI.
17. Preparing list of invitees, minute to minute Program etc.
18. Ensure PR / media / social media coverage of the event
19. Photography/Videography of the event.



20. Host unit shall mention "ASMITA" in all its communications.
21. Ensure participation certificates are distributed on a timely basis. Align Certification ceremonies with closing ceremony, Adequate media coverage Photographs, videos.
22. Only the approved Logo is used for all branding purposes.
23. The name of the competition shall mandatorily include key words like "ASMITA" Kickboxing City League
24. Waiver Form duly filled in capital letters and signed & sealed by the President / General Secretary of respective District, State Associations /UTs/ Units and Medical Form must done by the Licensed Doctor with signed and sealed from Native State/UT/Unit.
25. All are advised to follow the above guidelines and ensure a smooth and flawless execution of the event.
26. All Athletes mandatory to present during the Medical & Weighing process, if any one absent then we shall not entertain in the Championship.

**Important: SAI shall send observers to competition alternatively; the result sheet or any information may be shared by host unit.**
